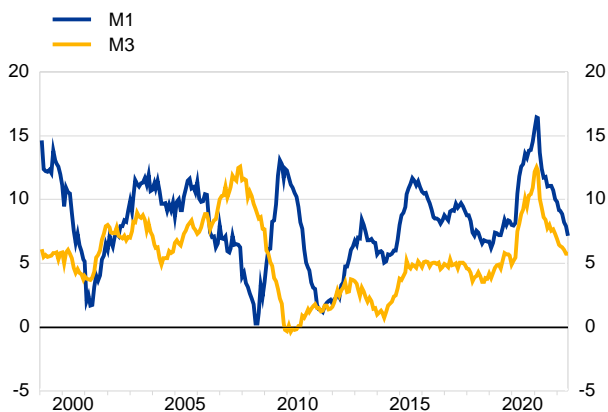

(annual growth rates; seasonally adjusted)

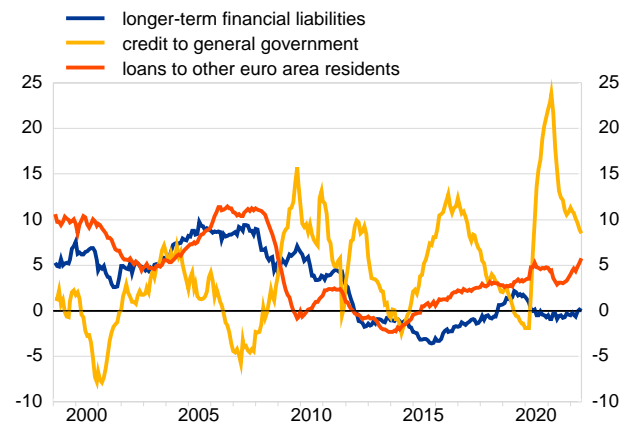

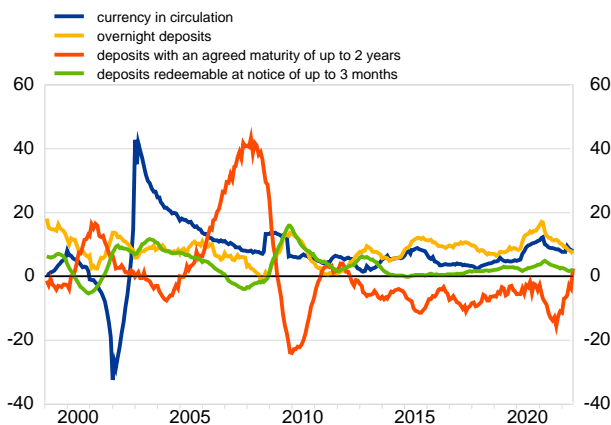

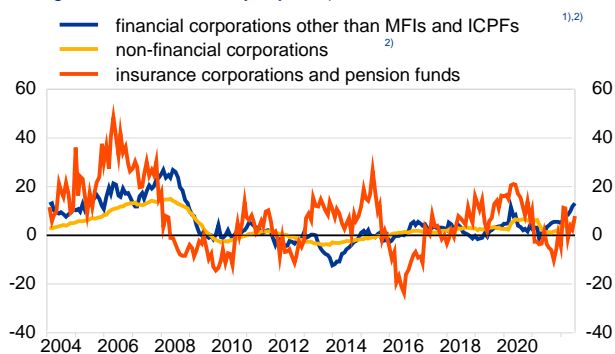

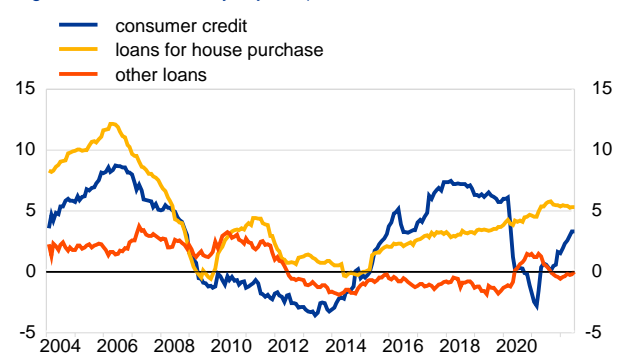
