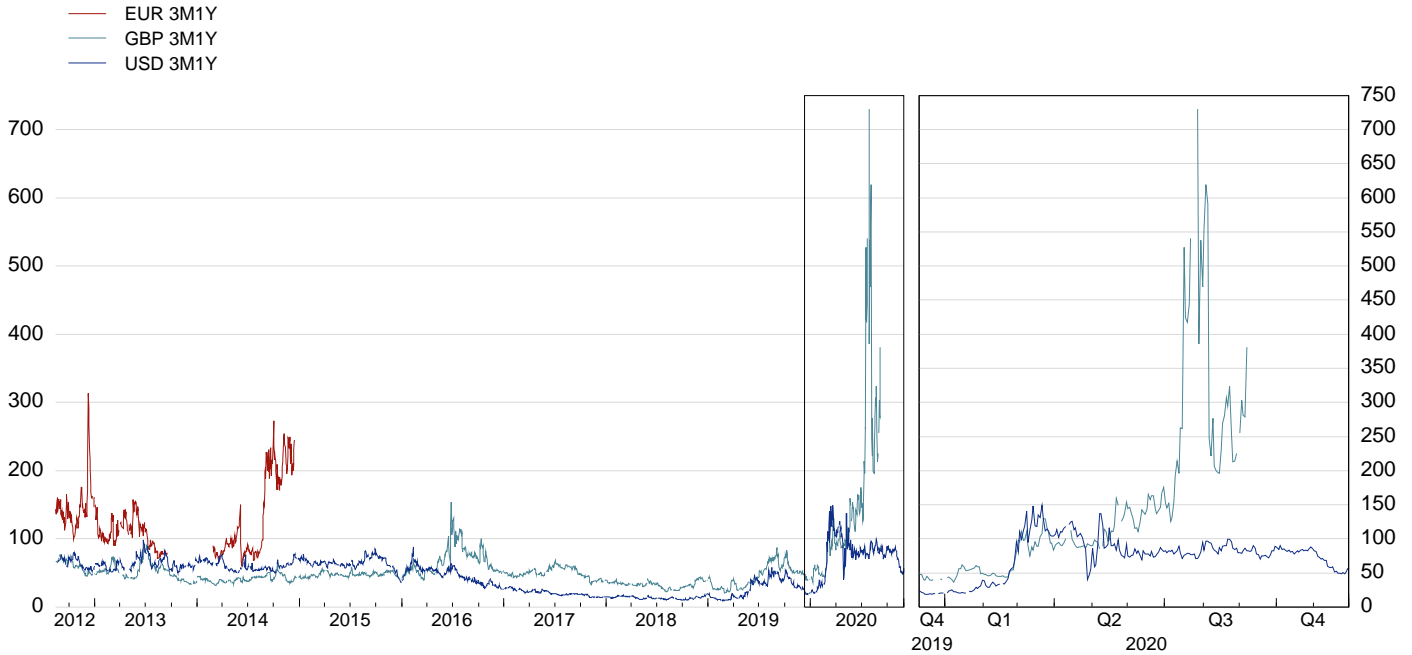

(three months - one year; last observation: 30 Nov. 2020)

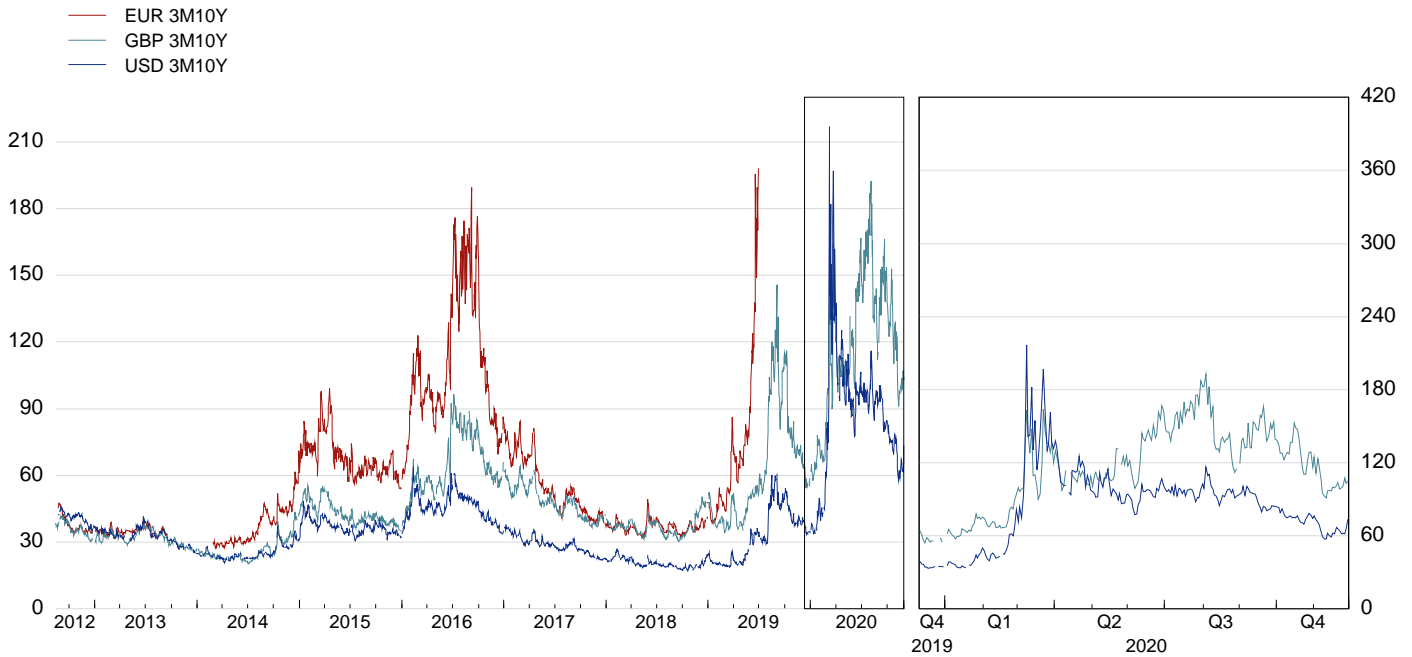
