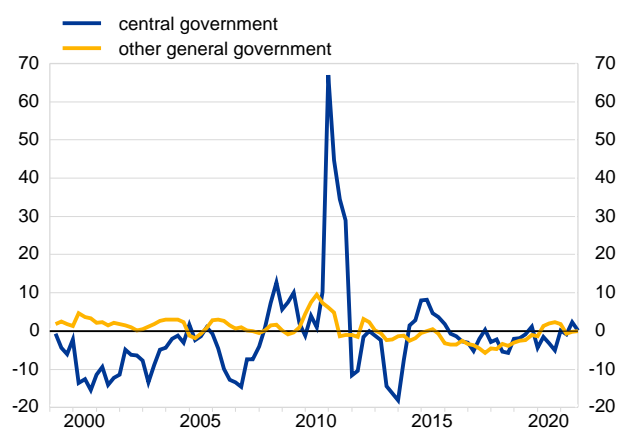

(annual growth rates; not seasonally adjusted)



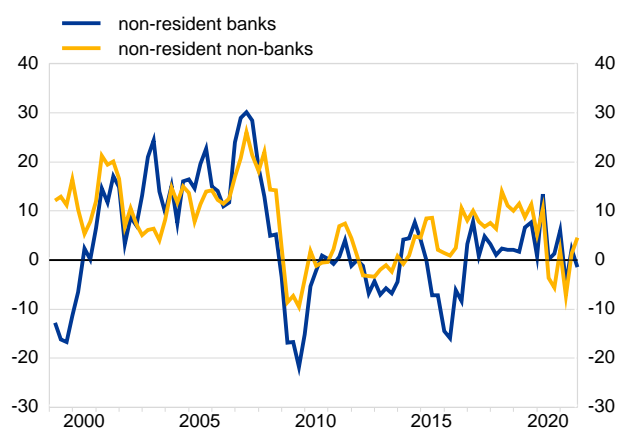
