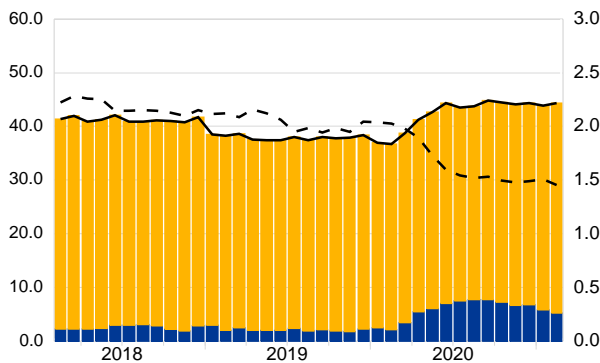

- - Average nominal yield (right-hand scale)

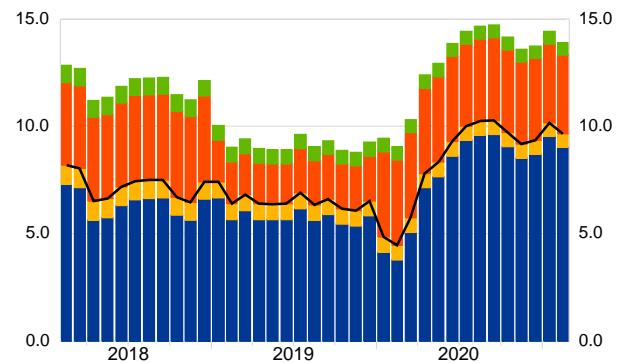
