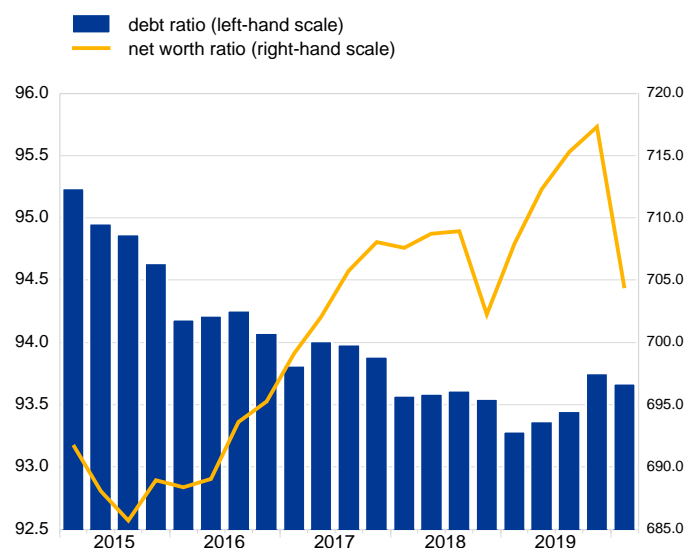

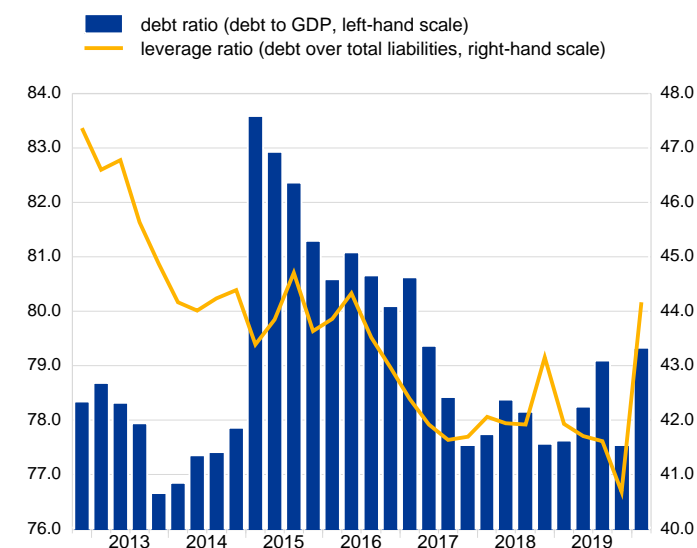
(percentages of adjusted gross disposable income)
